We would like to thank you for selecting **Fuso Italian Restaurant** for your event. In order to ensure successful and efficient events, the following policies will apply to all functions. Should there be any questions regarding the service policy, please feel free to contact Fuso Italian Restaurant.

### **PRICES**

**A \$75.00 Set Up fee will be charged to all parties 20 and under. There is a \$100.00 Set up fee for all parties over 20 Guests.**

The menu cost is based upon your initial guest count estimate and order selection. The final price may vary according to additional guests or selections ordered at the event. A guaranteed minimum guest count is required 3 days prior to your event. We will gladly accept a slight increase or decrease in your guest count, if necessary,

Tax and an 18% service charge are **not** included in your estimate. The room will be available for 4 hours for your event. **Additional charges may apply for events that exceed the 4 hour limit every house will be \$100.00 more., unless otherwise agreed upon by management.**

### **Holding the Banquet Room**

A \$400 deposit is required for the minimum food and drink charge is due at the time your reservation is made. With the \$400.00 deposit you are given a \$400.00 Fuso Gift Card to pay the final banquet bill. Any overages can be paid by M/C, Visa, American Express, Discover, or Cash.

For your protection, when alcoholic beverages are served at an event, we will follow the guidelines of the Responsible Alcoholic Beverage Council. We will observe the laws of the State of California prohibiting serving any minor or guest without a proper ID. We will also follow the laws of the Responsible Alcohol Council which says any guests who appear to be intoxicated will not be served any alcoholic beverages.

Corkage is \$14 per 750 ML bottle, \$18 per magnum sized bottle.

For any dessert brought in, the "cake cutting" fee is \$2.00 per person within the party.

### **CANCELLATION POLICY**

Your deposit of \$400 is **not refundable** if you cancel with less than **2 weeks notice** (14 days prior to your event). Upon receipt of the initial deposit, we will begin planning, scheduling and ordering for your event. We will give priority to your event and will avoid taking other business which may have a conflict. In addition, Fuso Italian Restaurant will require reimbursement for any non-refundable, out-of-pocket expenses incurred. The cancellation fee, and any other expenses incurred, will be billed to your account. The fees are due upon cancellation of your event.

**BREAKAGE AND LOSS**

Damages or losses to any property caused by the gross negligence or misconduct of the client, the client’s employees or guest, will be billed for repair and/or replacement. Clients acknowledge that due to the nature of this service, areas are requested to be hazard free with clear pathways. We request cooperation regarding the attention to safety and avoidance of accidents and damages. We require events within our building to meet required fire and building codes. We require any persons in your party consuming alcoholic beverages to be 21 or older, carrying a proper ID on them.

Children are not allowed to run through the building unattended, there is absolutely no running through the building, or through any of Fuso’s Patio areas.

In addition your \$400.00 deposit will be held if there are any damages caused by anyone in your banquet to any part of Fuso’s Equipment or buildings.

Please inspect the room you are using prior to your guest arriving.

**SECURITY POLICY**

Fuso Italian Restaurant reserves the right to require security guards and other protective services of any customer, if deemed necessary by the staff of Fuso Italian Restaurant at the cost of the customer.

**UNSERVED FOOD (For Buffets Only)**

For Health Department Laws, and for the fact that we prepare 5% to 8% over your final count to ensure proper coverage to you guests. Prepared foods that were not served to the clients will be property of Fuso Italian Restaurant.

**AGREEMENT**

This agreement may be terminated at any time by Fuso Italian Restaurant. It may not be assigned or otherwise transferred by the customer without expressed prior written consent by Fuso Italian Restaurant. Agreement of the customer to all foregoing terms and conditions is indicated by the signature below. This agreement becomes effective only when signed by the customer and Fuso Italian Restaurant representative. Upon receipt of the signed agreement it shall become a binding contract between us in accordance with its terms and conditions. Prices and dates are subject to change without notice.
